I understand that OTFM recommends that I carry my own liability insurance while participating in OTFM. I also understand there is no smoking on site at ANY venue the OTFM is located.

I, and all of my employees, volunteers, and guests, agree to and shall indemnify and hold Old Town Farmers Market (OTFM), Old Town Association (OTA), and City of Rock Hill harmless from and against all liability, loss, damages or injury, and all costs and expenses (including attorneys' fees and costs of any suit related thereto) suffered or incurred by OTFM, OTA, or City of Rock Hill, arising from participation in OTFM.
